I would like to acknowledge receipt of correspondence, which was received on January 18th, 2020, regarding the above noted project. As you may be aware, the area in which your project is proposed is situated within the Traditional Territory of Curve Lake First Nation. Our First Nation's Territory is incorporated within the Williams Treaties Territory and was the subject of a claim under Canada's Specific Claims Policy, which has now been settled. All 7 First Nations within the Williams Treaties have had their harvesting rights legally re-affirmed and recognized through this settlement.

Curve Lake First Nation is requiring a File Fee for this project in the amount of \$250.00 as outlined in our *Consultation and Accommodation Standards*. This Fee includes project updates as well as review of standard material and project overviews. Depending on the amount of documents to be reviewed by the Consultation Department, additional fees may apply. **Please make this payment to Curve Lake First Nation Consultation Department and please indicate the project name or number on the cheque.**

If you do not have a copy of *Curve Lake First Nation's Consultation and Accommodation Standards* they are available at https://www.curvelakefirstnation.ca/services-departments/lands-rights-resources/consultation/. Hard copies are available upon request.

Based on the information that you have provided us with respect to Claremont Drainage Plan, City of Pickering, Curve Lake First Nation may require a Special Consultation Framework for this project. Information on this Framework can be found on page 9 of our *Consultation and Accommodation Standards* document.

In order to assist us in providing you with timely input, it would be appreciated if you could provide a summary statement indicating how the project will address the following areas that are of concern to our First Nation within our Traditional and Treaty Territory: possible environmental impact to our

drinking water; endangerment to fish and wild game; impact on Aboriginal heritage and cultural values; and to endangered species; lands; savannas etc.

After the information is reviewed it is expected that you or a representative will be in contact to make arrangements to discuss this matter in more detail and possibly set up a date and time to meet with Curve Lake First Nation in person (or virtually).

Although we have not conducted exhaustive research nor have we the resources to do so, there may be the presence of burial or archaeological sites in your proposed project area. Please note, that we have particular concern for the remains of our ancestors. Should excavation unearth bones, remains, or other such evidence of a native burial site or any other archaeological findings, we must be notified without delay. In the case of a burial site, Council reminds you of your obligations under the *Cemeteries Act* to notify the nearest First Nation Government or other community of Aboriginal people which is willing to act as a representative and whose members have a close cultural affinity to the interred person. As I am sure you are aware, the regulations further state that the representative is needed before the remains and associated artifacts can be removed. Should such a find occur, we request that you contact our First Nation immediately.

Furthermore, Curve Lake First Nation also has available, trained Cultural Heritage Liaisons who are able to actively participate in the archaeological assessment process as a member of a field crew, the cost of which will be borne by the proponent. **Curve Lake First Nation expects engagement at Stage 1 of an archaeological assessment** so that we may include Indigenous Knowledge of the land in the process. We insist that at least one of our Cultural Heritage Liaisons be involved in any Stage 2-4 assessments, including test pitting, and/or pedestrian surveys to full excavation.

Although we may not always have representation at all stakeholder meetings, as rights holders', it is our wish to be kept apprised throughout all phases of this project. Please note that this letter does not constitute consultation, but it does represent the initial engagement process.

Good afternoon Julie and Kaitlin,

Thank-you for your letter (dated January 29) regarding the City of Pickering's Claremont Drainage Plan. As identified in your letter, there is a \$250 File Fee, which the City will pay to initiate review. We are making arrangements to have this payment made.

With respect to your request for further detail, we offer the following about potential impacts.

- Drinking water: There are no anticipated impacts to drinking water based on an improved storm sewer system and drainage system in the Hamlet of Claremont.
- Endangerment to fish and wild game: There are no expected impacts to fish and wild game based on improving the Hamlet's drainage system (roadside ditches, and rear yard drainage swales).
- Aboriginal heritage and cultural values: A Stage 1 Archaeological Assessment (AA) has been conducted and a Stage 2 AA is recommended for areas not within road right-of-way. Most of the drainage improvements would be located within municipal road right-of-way; however, should alternatives be recommended outside the road right-of-way, the Stage 2 AA would be required.
- Endangered species, lands, etc.: It is understood from the Toronto Region Conservation Authority,
 that Redside Dace exist south of the Hamlet, as such any drainage improvements will be required to
 apply appropriate erosion and sediment controls. In addition, the tributary of Duffins Creek,
 commencing immediately south of Central Street, and west of Barclay Street, will be required to
 maintain the flow range directed to it from the existing storm sewer system on Central Street.

We would like to request the opportunity to discuss the project with you via a virtual meeting, and to better understand the Special Consultation Framework needs. Understanding that you're booking in April and beyond, could you suggest some days/times that would work best for you?

Thank-you for your letter (dated January 29) regarding the City of Pickering's Claremont Drainage Plan. As identified in your letter, there is a \$250 File Fee, which the City will pay to initiate review. We are making arrangements to have this payment made.

With respect to your request for further detail, we offer the following about potential impacts.

- Drinking water: There are no anticipated impacts to drinking water based on an improved storm sewer system and drainage system in the Hamlet of Claremont.
- Endangerment to fish and wild game: There are no expected impacts to fish and wild game based on improving the Hamlet's drainage system (roadside ditches, and rear yard drainage swales).
- Aboriginal heritage and cultural values: A Stage 1 Archaeological Assessment (AA) has been conducted and a Stage 2 AA is recommended for areas not within road right-of-way. Most of the drainage improvements would be located within municipal road right-of-way; however, should alternatives be recommended outside the road right-of-way, the Stage 2 AA would be required.
- Endangered species, lands, etc.: It is understood from the Toronto Region Conservation Authority, that Redside Dace exist south of the Hamlet, as such any drainage improvements will be required to apply appropriate erosion and sediment controls. In addition, the tributary of Duffins Creek, commencing immediately south of Central Street, and west of Barclay Street, will be required to maintain the flow range directed to it from the existing storm sewer system on Central Street.

We would like to request the opportunity to discuss the project with you via a virtual meeting, and to better understand the Special Consultation Framework needs. Understanding that you're booking in April and beyond, could you suggest some days/times that would work best for you?

1.1 Indigenous Engagement

Indigenous engagement is a key component of the Class EA process. The Ministry of the Environment, Conservation and Parks (MECP) delegated the procedural aspects of the duty to consult to the City of Pickering (City) in its response to the Notice of Commencement on December 7, 2020.

Copies of all Indigenous engagement documents can be found in appendix N.

1.1.1 Identification of Indigenous Nations

In consultation with the MECP, the City sought direction on the identification of Indigenous Nations that may have an interest in the Municipal Class Environmental Assessment. Request for confirmation was submitted to the MECP on December 7, 2020. Upon confirmation from the MECP, an email including the Notice of On-line PIC were sent to the following Indigenous Nations on November 20, 2020:

- Alderville First Nation (AFN);
- Curve Lake First Nation (CLFN);
- Hiawatha First Nation (HFN); and
- Mississaugas of the Scugog Island First Nation (MSIFN);

Based on understood Indigenous Nation specific consultation protocols, individual communications were issued to the Nations. Due to the COVID-19 pandemic, several Indigenous Nations identified preference for communications to be through email only. The Nations were initially contacted on August 8, 2021, and August 19, 2021. These two communications shared details about the second online engagement event that took place between August 19 to September 16, 2021.

1.1.1.1 Alderville First Nation

Following the August 8, 2021 correspondence, a phone call was held between AFN and WSP. As a follow-up to the phone call, WSP sent an email on August 19, 2021 to inquire if the Nation had any comments or concerns about the Project. AFN responded and identified they had no concerns and that they would be interested in the study reports (e.g. Species at risk, archaeological reports). WSP responded stating that the Nation would be kept informed about their items of interest.

1.1.1.2 Curve Lake First Nation

On February 2, 2021, CLFN sent an email containing a letter which outlined the Nation's concerns with the Claremont Drainage Plan. CLFN was concerned about the drinking water, the endangerment of fish and wild game, as well as the potential Aboriginal heritage that could be

discovered. WSP responded to these concerns on April 1, 2021, and offered to discuss the project further via a virtual meeting.

WSP followed up with CLFN on July 20, 2022 to better understand CLFN's Special Consultation Framework and discuss some of the concerns raised in February 2021. WSP offered to set up a meeting to discuss the Project and reminded CLFN of the PIC materials available for review and comment. WSP followed-up on via phone call and email on July 28, 2022. On August 2, 2022, Francis Chua Consulting, on behalf of CLFN responded identifying that there is interest in having a meeting and provided suggested dates and times. WSP followed-up on August 8, 2022 and September 8, 2022 to confirm the date and time for the meeting. No further response was received from Francis Chua Consulting or CLFN.

1.1.1.3 Hiawatha First Nation

Following the August 8, 2021 correspondence, HFN responded and identified that they had no questions or concerns at this time.

1.1.1.4 Mississaugas of the Scugog Island First Nation

WSP followed up with MSIFN on July 20, 2022 to share the Project website and request any comments or concerns on the Project. On the same day, MSIFN responded noting that they reviewed the Project website and do not have any comments on the PIC materials. However, MSIFN requested the Master Plan Report for review when it is completed.
