1 BUILDING C - SOUTH ELEVATION 1: 250






VIEW FROM WALNUT LANE LOOKING WEST






VIEW FROM STREET A LOOKING NORTH EAST




VIEW FROM KINGSTON ROAD LOOKING SOUTH




VIEW FROM KINGSTON ROAD LOOKING SOUTHWEST
