No person shall sell any goods, wares, merchandise or foodstuffs other than those indicated on the licence. Any person required to be licenced pursuant to this by-law, shall at all times while carrying on the business of a Hawker or Peddler, have the licence displayed in a conspicuous place and shall upon demand, exhibit it to any Municipal Law Enforcement Officer, Peace Officer, or to any person to whom the Hawker or Peddler is offering goods for sale.
